What is the NSAPDP?



A public, autonomous and independent central authority.

It protects your right to privacy (intimate, family and private life) concerning the processing of your personal data.

What can the NSAPDP do for you?

It protects your personal data when the data is being:

- processed through automatic means (e.g. by a computer)
- processed within an evidence system (e.g. physical registry, on paper support)
- processed within the territory of Romania (embassies and consular offices included) or by persons (controllers) located in Romania

What are your rights?



- 1. The right of (free) information:
- by the data controller, when he collects your data or, at the latest, at the moment of the first communication, before revealing your data to third parties;
- regarding: who the controller is, the purpose of the processing, the possible recipients, if you are obliged to provide it with all the data requested and what might be the consequences of your refusal, what rights you have and how you can exercise those rights;
- 2. The right of access (once a year free of charge):
- you may demand from the controller, in writing, under signature and date, to communicate to you if he is processing your data, the purpose of the processing, the data processed, the recipients, the source of the collection, the automatic means of processing it uses and what rights you have;
- 3. The rights of intervention (free):
- you may ask the controller, in writing, under signature and date, to rectify or upgrade your date

OR

- to block the processing of data, to erase or not to reveal the data, to transfer the data into anonymous data in case the controller processed them illegally

OR

- To communicate to the recipients any stage you asked for (rectification, upgrading, erasure etc.)

- 4. The right of opposition (free):
- you may ask the controller, in writing, under signature and date not to process your data for the purpose of direct marketing or to reveal the data to third parties
- 5. The right not to be subject to any automatic individual decision:
- you may demand from the controller for the withdrawal, cancellation or reevaluation of the decision issued exclusively by using automatic means which evaluate your professional competency, credibility or behavior, under certain conditions
- 6. The right to lodge a complaint to the NSAPDP (free):
- you can notify us regarding any infringement of your rights, concerning the processing of your personal data and if the controller does not observe your rights, granted to you by Law no. 677/2001
- First of all, you must address to the controller, 15 days earlier before notifying the NSAPDP
- 7. The right to consult the Registry of the personal data processing evidence (free):
- you can verify whether a controller has announced (notified) to the NSAPDP the processing of personal data and the terms of the processing
- 8. The right to address to the court of law (free):
- you may bring an action in front of a court of law against any controller which did not respect your rights or which caused you some damage by any illegal processing of data
